Closure of Streets to Ordinary Vehicular Traffic

PURSUANT TO THE LOCAL GOVERNMENT ACT 1974, notice is hereby given that consideration will be given, at the Regulatory and Hearings Committee meeting, Council Chambers, Gorge Road, Queenstown on Tuesday, 7th October, 2003 at 12.30pm, to the closure of the following roads to ordinary vehicular traffic:

For the purpose of holding the SBS ITU Triathlon World Championships

ARROWTOWN WELCOME PARTY
The event is a welcome party to be staged on Buckingham Street and adjacent footpaths.

Roads to be Closed: Buckingham Street (between Berkshire and Wiltshire Street).

Period of Closure: 4.00pm to 10.00pm Tuesday, 2nd December, 2003.

KIWI KIDS TRY-ATHLON
The event is a children's triathlon, to be staged on the Glenorchy-Queenstown Road, Lake Esplanade and adjacent footpaths and reserves.

Roads to be Closed: Glenorchy-Queenstown Road (between the two Fernhill Road intersections) and closure of the lakeside parking bays on Lake Esplanade between Fernhill Road and the Steamer Wharf.

Period of Closure: 10.00am to 2.00pm Wednesday, 3rd December, 2003.

It is a requirement of the International Triathlon Union (ITU) that roads are completely closed for the period that cyclists are on the course. This means there are no windows for resident access during the road closure times.

It will be an offence under the above regulations for any person otherwise than under authority of an authorised permit to use the roads for ordinary vehicular traffic during the period of closure.

PUBLIC NOTICE OF THE OPERATIVE DATE OF THE QUEENSTOWN LAKES DISTRICT PLAN

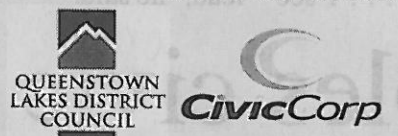

Queenstown Lakes District Council Proposed Bylaw

LIQUOR (CONTROL OF LIQUOR AND VEHICLES IN PUBLIC PLACES) BYLAW 2003

Pursuant to Section 83 of the Local Government Act 2003, the Queenstown Lakes District Council gives notice that the special consultative procedure in respect of this proposed bylaw has commenced.

SUMMARY OF PROPOSAL

BACKGROUND

During the last two New Year periods, a seven-day liquor ban was imposed in the lakefront and central commercial area of Wanaka. Seven-day liquor bans were also used in Queenstown and Arrowtown during the 2002/2003 New Year.

The bans were found to be a successful way of improving public behaviour and reducing antisocial behaviour in these areas. Changes to the Local Government Act mean that the bans previously implemented by Council resolution would now need to be implemented via a bylaw.

Initial consultation with community groups and business organisations has indicated that there is much support for a bylaw in the form proposed.

AIMS OF THE PROPOSED BYLAW
The aims of the bylaw are:

- Protecting the public from nuisance.
- Protecting, promoting and maintaining public health and safety.
- Minimising the potential for offensive behaviour in public places.

On 22nd August, 2003, the Queenstown Lakes District Council initiated the process of investigating a bylaw relating to controlling liquor and vehicles in public places. A working party was convened and a draft bylaw has now been formulated.

The Council has considered a range of alternatives but has determined that a bylaw is the most appropriate way of addressing the problem. A copy of a report containing an assessment of these options is available on request.

The Council has also considered whether the proposed bylaw gives rise to any implications under the New Zealand Bill of Rights Act 1990 and has concluded that it does not.

THE DRAFT BYLAW
The draft bylaw defines the specified times, dates and places where liquor would be prohibited in public places over the Christmas and New Year period. (8.00pm on 27th December till 8.00pm on 5th January).

The public places where the liquor prohibitions and associated vehicle controls are scheduled in the draft bylaw. They are generally the central commercial and lakefront areas of Queenstown and Wanaka and the central commercial, reserve and riverside areas of Arrowtown.

The bylaw also proposes a ban on overnight parking on the Wanaka lakefront during that period.

The bylaw would also give the Council the ability to impose a liquor ban on other occasions or in additional public places by resolution if required.

The bylaw would give Police the ability to search containers and vehicles, to seize liquor if the liquor is in a public place in breach of the bylaw and to arrest a person found to be committing an offence against the bylaw.
