Background and Comment

- 1 The QAC is a Council Controlled Trading Organisations (CCTO) as per Section 6 of the Local Government Act 2002 (the Act). Section 64 of the Act requires all CCTOs to have a Statement of Intent.
- 2 The Statement of Intent for 2015/16 requires QAC to provide an unaudited half yearly report to the shareholder (Council) within two months of the end of the first half of each financial year.
- 3 The attached reports comprise the following statements for the six month period ended 31 December 2015:

 - Management Report for the period

Options
