The said Order shall apply to all shops in the following area: (full description of boundaries required) All that area comprised within a radius of 35 kilometres from the Post Office premises situated on the corner of Camp Street and Market Street, Queenstown but excluding therefrom the area comprised within a radius of 1 kilometre from the Post Office in Kingston.

The said Order is granted subject to the following conditions:

There shall be no requirement in terms of employment for permanent employees that they must work on Sundays and

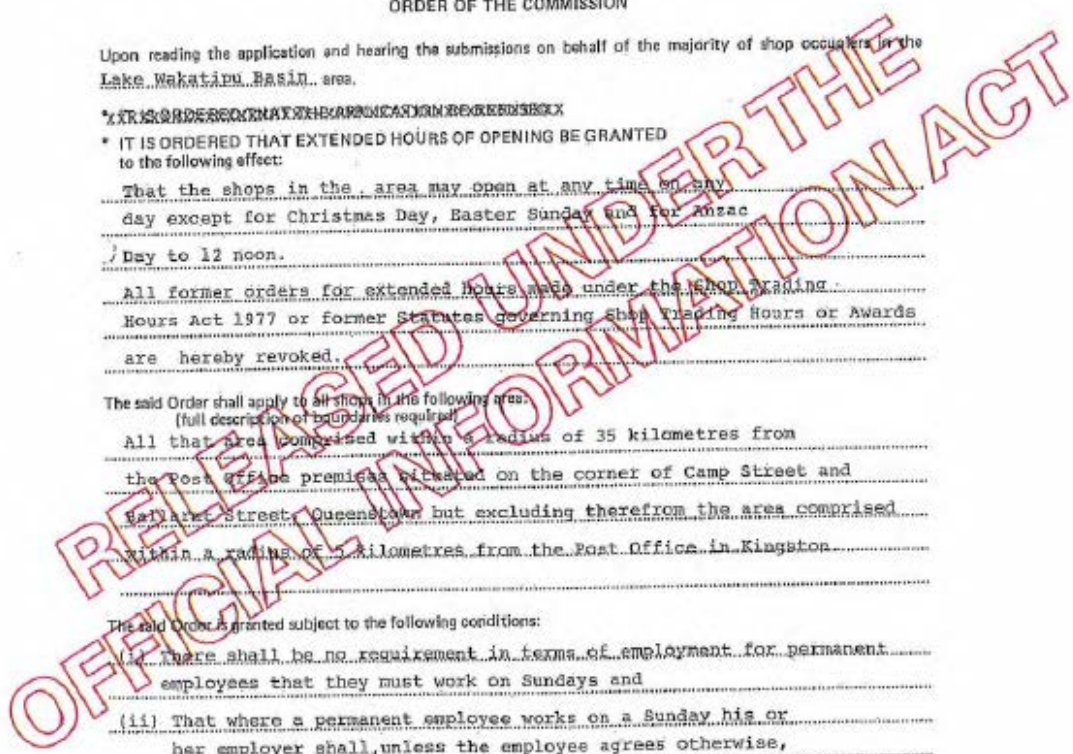
(ii) That where a permanent employee works on a Sunday his or her employer shall, unless the employee agrees otherwise, provide two consecutive days off for that employee each working week.

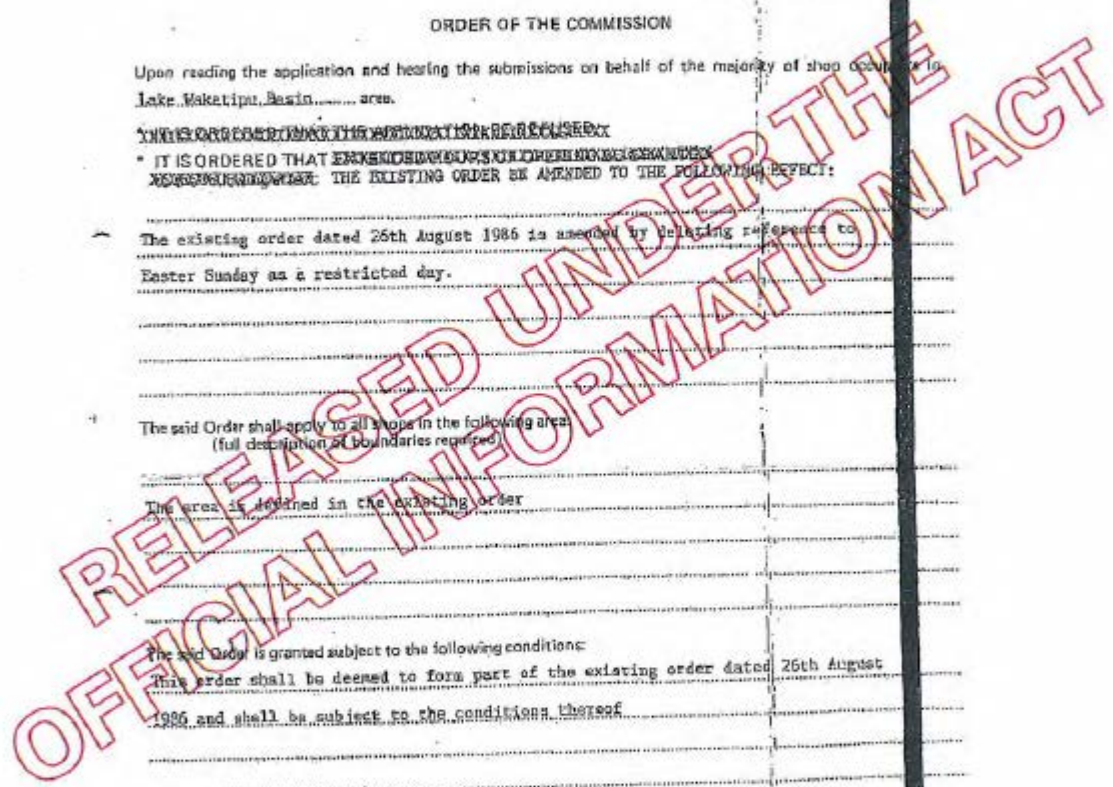
