





#	Response: Should busking be permitted?
1.	Busking should be kept to a minimum
2.	Restricted to noisy areas away from accomodation and businesses that rely on a certain ambience such as restaurants.
3.	So long as it is not obstructing businesses or vehicle/foot traffic. Current hot spots (Queen St Mall, Lakefront etc) are great spots already, especially for tourists and locals to enjoy when roaming the township.
4.	Definitely but permit for specific areas and only if approved by the shop premises they choose to do it in front of
5.	I love it but attracting big crowds in the middle of no man's land drives me nuts trying to get through
6.	But a permit should be granted, as some certain buskers are not so good on the ears! A busker night along with night market night would be awesome!
7.	They are often near the lake front on the corner of Ballarat street with the lake front blocking the beautiful lake view and probably disturbing tourists and Prime restaurant patrons.
8.	With a permit and Agreement from nearby shops etc
9.	Only in open spaces where it doesn't affect shops/restaurants. So on the green is fine, but perhaps not down the mall
10.	This does create a great atmosphere in places, when they are good, some are just very bad
11.	This peak season (2015/16) has had FAR too much musical overlap with as many as 4 (four!) buskers at once on the mall, each attempting to overpower the next, resulting in a cacophony of noise. I stopped frequenting establishments due to this.
12.	In town in specific locations, not along the lakefront tracks.
13.	Same as comments for fundraising and canvassing too much can be frustrating no problems at all with busking though.
14.	By specifying locations you can limit the 'environmental noise' that can occur from too many performers trying to take centre stage in the one space. Specific locations allows buskers to share their talents without competition.
15.	I think busking is awesome in public, on the streets, parks, beaches etc and adds atmosphere to our town. Definitely reasonable noise limits within residential areas though.

16.	Busking is wonderful but should be allowed in certain areas such as parks, green areas and areas of high foot traffic in town. If they were allowed anywhere they might camp out in inconvenient spots and become a nuisance.
17.	I believe that busking should be permitted in certain locations however a time limit should be placed on the length of time they can play. Depending on the music (and the talent of the busker!) it can be incredibly irritating for people working in businesses in close proximity to buskers. Before being given a permit to busk, I believe that Council should communicate with businesses in the vicinity.
18.	Buskers should not be near other music sources. Specify enough distance from other buskers or businesses playing music so that it is not an assault on the senses. Ensure that there are busking free areas where people can relax as some buskers are not particularly good

25.	Should register
26.	We have a busker who sits below our window. Our office is located at 22 Ballarat St (the Mall) above Louis Vuitton. I would have agreed that buskers should have designated locations had I not experienced this person for the last 2 months (since we moved in in October). This guy sits and plays the same 6-10 tunes in the same order again and again EVERY SINGLE DAY! He is driving us NUTS. We can't drown him out with our radio (even if it is on very loud) as we have single glazed windows and he is right below. I don't know how you can stop this except for allowing him to busk anywhere so that he wouldn't be driving us nuts playing the same stuff the same time (for hours!) each day! Either that or he has to play for a lot less time, or move on after a month to another location. Its literally enough that our staff are ready to go and yell at him, or cause a more serious fracas. So something needs to be done. Please help!!
27.	'Busking', now there is a curly subject. We currently have, what I consider to be, fair conditions for buskers to agree to when they uplift their permits. These conditions are routinely ignored by almost every busker who comes here. In fact few buskers have permits. I consider it a privilege for people to come here for a couple of weeks or so, and use our streets and tourists for their own gain. I frequently witness what I consider to be abuse of this privilege. I think there should be more restrictions on where they may busk. The present rules are very open. I have issues with the volume of most amplified music on the streets and with the obstruction of pedestrian flow. When we designed and upgraded, paved and installed street furniture at the confluence

of TheMall/ TownPier/ LakesideBoardwalk, it was intended as an open space affording wide views, a meeting place and ease of foot in any direction. It has become the street performer's stage with often a mere two metre path along the lake wall the only freeway. The performers dominate this space aggressively from mid-late afternoon continuously through until 2200hrs and later sometimes. This is not the correct location for these large space performances and the performers disrespect our wishes and conditions. We need to create an appropriate space elsewhere for these types of acts. Some Councils in NZ have quality control over who may and may not busk on their streets. After some of the 'acts' I've watched this summer I can see why. Some visiting here wouldn't get through the audition round of 'Invercagill's Got Talent'! and then they have the cheek to hustle the audience for \$20 donations. When the Council, in it's wisdom, changed the busking rules not too long ago apparently, to allow amplification, they must not have foreseen the recent technological improvements in small, mobile amps and speaker systems. Buskers playing, usually their guitar, can often easily be heard two blocks away. This is ridiculous. Louder and LOUDER does not equate to more vibrant. This is not a comment on talent or lack of. Some of these musicians are really good but it's a pub gig, on the street. Too much night-time Courtney Place, not enough get-away-from-it mountain resort. We don't want or need busking in the Gardens, or even along Bikini Beach (no comment on the DJ's there. It's a different issue). Can we please retain some spaces where one can read a book in quiet or have a conversation without the need for raised voices? Silence is more golden than ever.

9.	Smoking is a public menace, it is horrible walking in fresh air and smelling cigarette smoke, or when you come out of an arcade, or shop. QT is a green and outdoor spot, so should be smoke free and healthy.
10.	Not on beaches, parks,playgrounds etc.
11.	I hate walking out of shops, down the street, out of restaurants, at the bike parks, lake front etc to constantly get second hand smoke blown in your face, there are way too many smokers who do not have nay respect for others around them/non-smokers. There are constantly cigarette butts thrown on the ground, and in town where there are smokers bins, they are barley used correctly and ends up being overflow of cigarettes.
12.	As I'm sure you are aware it would be better if more people used public transport, I did my bit for the community approx 4-5months ago, I got the bus into town with my newborn only for disgusting people to blow smoke around me while I was depart bus and waiting to board again. I was appalled that people were all smoking around the entrance to the mall. My partner smokes (unfortunately) & I am an ex smoker but I think that it shouldn't be allowed in the CBD, it's common in other countries to ban smoking on the street so we should also follow thier lead.
