- 1 The parties listed in **Appendix A** to this Notice (**Parties**) wish to be parties pursuant to section 274 of the RMA to the following proceedings:

Well Smart Investments Group v Queenstown Lakes District Council (ENV-2019-CHC-017) (**Well Smart Appeal**) being an appeal against decisions of Queenstown Lakes District Council on Stage 2 of the Queenstown Lakes Proposed District Plan (**PDP**).

- 2 The Parties are persons who made a submission about the subject matter of the proceedings.
- 3 The Parties are persons who have an interest in the proceedings that is greater than the interest that the general public has, and in particular is the provider of public and tourism-related transport and tourist activities which require earthworks, transport and visitor accommodation to support these activities.

- 6 Without derogating from the generality of the above, the Parties are interested in the following particular issues:

Chapter 25 (Earthworks)

- (a) Changes to earthworks provisions to remove unnecessary resource consent requirements.

Chapter 29 (Transport)

- (b) Changes to the transport chapter as identified in the original submission.

Visitor Accommodation Variation

- (c) Changes to the visitor accommodation provisions to better recognise the benefits of commercial visitor accommodation activities.

- 7 The Parties support the relief sought in part, insofar as it is consistent with the relief sought in each of the Parties appeals.
- 8 The Parties agree to participate in mediation or other alternative dispute resolution of the proceedings.
