

**Queenstown Lakes District Council Proposed District Plan – Stage 2  
Addendum to Summary of Decisions Requested for Submissions  
2662 – Relax it's Done Limited and  
2663 – Aircraft Owners and Pilots Association of New Zealand**

**Omission from Original Summary of Decision Requested**

On 12 April 2018 Queenstown Lakes District Council publicly notified the summary of decisions and omitted a submission made by Relax it's Done Limited (Submission #2662) during the original submission period which was misdirected.

The submission relates to the proposed provisions on Visitor Accommodation.

**Submission on Variation to Chapter 24 – Wakatipu Basin**

On 23 November 2017 Queenstown Lakes District Council publicly notified Stage 2 of the Proposed District Plan. Due to an error, an incomplete version of Chapter 24 – Wakatipu Basin which omitted Table 24.2 - Activities in the Wakatipu Basin Lifestyle Precinct was available on the Queenstown Lakes District Council website from 23 to 28 November 2017 before it was corrected.

On Thursday 9 August 2018 Queenstown Lakes District Council publicly notified a Variation to Chapter 24 – Wakatipu Basin, to allow any person who was not aware of the proposed Table 24.2 to make a submission on those proposed provisions.

A submission on this variation has been received from the Aircraft Owners and Pilots Association of New Zealand (Submission #2663).

- (c) The local authority itself.

**What can a further submission cover?**

Further submissions must be limited to matters **in support of or in opposition** to a matter raised in an original submission.
