1. Introduction

- 1.1 My full name is James John Cavanagh of 82 Jacks Point Rise, Jacks Point, Queenstown.
- I am employed by the Imperium Group ("Imperium") as the General Manager of The Spire Hotel ("The Spire") and Eichardt's Private Hotel ("Eichardt's). I am authorised to give evidence on behalf of Imperium.
- 1.3 Imperium is a Melbourne based company owned by Andrew Cox. Imperium is comprised of a number of businesses including the franchise business TGI Fridays throughout Australia, Australian Graphic Supplies Pty Ltd based in Brisbane, Wardrobe World which has a dealer network throughout Australia and the Melbourne Rebels Rugby Union Pty Ltd.
- 1.4 The Spire and Eichardt's form part of the Imperium Collection of hotels. Imperium Group Holdings Limited has operated the two hotels since 2010 (Eichardt's) and 2014 (The Spire). These hotels pride themselves on the ability to give our guests a luxurious and stay without interruption and disturbance.

2. Submission and further submissions

2.1 Imperium filed a submission on the Proposed District Plan ("PDP") (#151). Generally speaking, Imperium's submission focused on its concerns about adverse noise effects on its existing premises arising from the less stringent noise rules proposed for the Queenstown Town Centre Zone (and the Town Centre Entertainment Precinct in particular). Imperium also lodged various further submissions supporting and opposing original submission of other submitters (#1318).

3. Current and past noise environment

- 3.1 In my time at The Spire and Eichardt's, both hotels have experienced a number of complaints from guests regarding the noise emanating from Vinyl Underground, The Club, The World Bar and Winnies.
- 3.2 On 2 March 2015 at a hearing of the District Licensing Committee in respect of the application from Badger Bars Limited for a new on-licence for "Vinyl Underground", Rahul Sharma and I gave evidence regarding the number of noise complaints The Spire had received as a result of excessive noise. Rahul Sharma was the night auditor employed by The Spire at that time.
- 3.3 Rahul referred to numerous occasions on which he had been required to call Noise Control, between 25 October 2014 and March 2015. The complaints dealt with by Rahul are set out in Annexure "A". These complaints relate to bass noise, loud music and yelling from patrons of the neighbouring licensed premises.
- 3.4 As a result of District Licensing Committee hearing, the trading hours for "Vinyl Underground" were reduced. The premises were only permitted to trade until 2.00am.
- 3.5 This year we have received a number of complaints from guests at The Spire regarding the noise levels at "The World Bar", "Vinyl Underground" and "The Club".
- 3.6 The management of these premises simply do not consider the effects of our guests when taking kegs outside or music equipment or when moving outside furniture in the early hours of the morning, or simply leaving open doors or windows.

- 3.7 We have filed objections with the District Licensing Committee in respect of applications from these premises for liquor licences pursuant to the Sale and Supply of Alcohol Act 2012. The objection in respect of "The World Bar" was subsequently withdrawn as a compromise position was reached and the management of "The World Bar" agreed to amend its application to seek trading hours until 2.30am. The original application requested trading until 4.00am each day.
- 3.8 We have also received complaints from guests at Eichardt's in respect of noise coming from a bar in the Mall, known as "Winnies".
- 3.9 On a number of occasions we have been required to call the Noise Control Service to report the noise levels which have been unacceptable, and have interrupted our quiet enjoyment of both hotels. This has been extremely detrimental to our operations. Guest complaints have been frequent. The complaints can lead to negative reviews on sites such as Trip Advisor and this has an effect on us in the longer term, as well as damaging our reputation in the eyes of influential travel agents.
- 3.10 The complaints received since 3 June 2015 are summarised in Annexure "B". This noise is created by loud music, especially when doors are open and the noise of people exiting the premises in the early hours of the morning.
- 3.11 Our guests complain to the reception staff and the management about the interruption to sleep. Some have booked for several nights but cancel after the first night.

- 3.12 We have also found the response from the Council staff and the staff employed by the after-hours Noise Control Service to be ineffectual. The Council does not appear to enforce the noise limits.
- 3.13 The contractors who deal with after-hours complaints do not promptly respond to complaints. They also have unreasonable requests such as wishing to speak to our guests and to enter the guest rooms.

4. Noise insulation

4.1 The costs for The Spire and Eichardt's to retrofit sound proofing to deal with increased noise levels in the Town Centre would easily be upwards of \$100,000.00.

5. Summary

5.1 In summary, Imperium requests that Council take account of the amenity of existing noise sensitive premises when reviewing noise levels in the Town Centre Zone.
