But I will share what I know about this request. The trees in question are within an internal area of the golf course on the back side, not seen by the public unless the public are playing golf or walking through the middle of the reserve. The trees are in an area between holes 12 and 17, not near any boundary. The reason for the application for a water reserve is to be a more environmentally friendly and sustainable golf club. Catching our own water for irrigation will only astion the ORC's goal to reduce water take and improve water usage. The 2 for 1 tree replacement policy will mean the re-planting of 140 trees which will offset the carbon emissions goal plus keep the parkland feel of the golf course if these 70 trees are removed. If these trees were on a BOUNDARY of the golf course, it would be a different issue. Boundary planting on golf courses is essential in order to keep stray golf balls within the golf course. No-one wants to see large nets and fences structures replacing beautiful trees, but in this case it will be a pond with native planting around it. The Golf course is a recreation reserve, but it is a cored for Golf, so the rules for recreation reserves also need to take into consideration the zoning for golf activity. The land is not like a public park, it is a golf course with a lease in perpetuity, so will always be a golf course. So I hope that QLDC will approve the internal tree removal request.

A juvenile tree is not a substitute for a matured tree in that respect. In fact it is only in the latter life of a tree that the sequestring comes into full effect. If gloc is sincere in its commitment to attend to a global and local climate crises, as it has declared, then convenience to locate water tanks in lieu of the space occupied by mature trees is folly. Global warming is an accepted reality so please look again at where these water tanks can be installed.
