CONTEXT | HOROPAKI

Representation Review

1. The Council adopted its final representation review proposal at the Council meeting held on 16 September 2021. The detail of the final proposal is as follows:

On the motion of Councillor Shaw and Councillor MacLeod it was resolved that the Queenstown Lakes District Council:

- 1. Note the contents of this report;
- 2. Adopt for its final proposal pursuant to Section 19H of the Local Electoral Act 2001:
 - a. That all Councillors are elected in wards;
 - b. The names of the wards shall be: Queenstown-Whakatipu, Arrowtown-Kawarau and Wānaka-Upper Clutha;
 - c. The boundaries of the wards shall be:
 - i. The boundary of the Wānaka-Upper Clutha Ward will be the same as the present Wānaka Ward;

- ii. The boundary of the Arrowtown-Kawarau Ward will be 3038701, 3038702, 4014322, 4014303, 4014329, 4014328, 3039504, 3038219, 3038106, 4001028, 4001203, 4016932, 4018096, 4001213, 3039727, 4001031, 4014322, 4015842, with the interior including the full area of the present Arrowtown Ward;
- iii. The boundary of the Queenstown-Whakatipu Ward will be 4014604, 4010455, 4014325, 3039405, 4015498, 3038202, 4011608, 4011609, 4010439, 4010440, 4000500, 4010438, 4017638, 3040001;
- iv. Four Councillors will be elected by the voters in the Queenstown-Whakatipu Ward, four Councillors will be elected by voters in the Wānaka-Upper Clutha Ward and three Councillors will be elected by voters in the Arrowtown-Kawarau Ward;
- 3. Adopt for its final proposal pursuant to S19J of the Local Electoral Act 2001 that there shall be a Wānaka-Upper Clutha Community and a Wānaka-Upper Clutha Community Board comprising four members elected directly by voters in the Wānaka-Upper Clutha Ward as a whole and three of the four Wānaka-Upper Clutha Ward Councillors as appointed members (to be appointed by Council);
- 4. Note that following the representation review outcomes a workshop has been scheduled with the Wanaka Community Board for 28 September 2021 to review the Governance Protocol Statement and identify future initiatives for the Board;
- 5. Note that appeals and objections to the final proposal may be received until 5.00pm on Friday, 22 October 2021; and
- 6. Formally thanks the members of the Representation Review Advisory Group.
- 2. Because the Council has changed its proposal from what was initial resolved, both a right of appeal and objection exists. Submitters have a right of appeal, but only in relation to a matter already contained in their original submission. All members of the public have a right of objection, but any objection must identify the specific matter/s within the final proposal to which the objection is raised. The period of appeals/objections must be open for at least one month and the Council has agreed that it will close at 5.00pm on 22 October 2021.
- 3. Appeals and objections are collated by the Electoral Officer and then forwarded to the Local Government Commission. The Council must also supply the Commission with the following documentation (as set out in section 19Q of the Local Electoral Act):
 - a. The original and final resolutions;
 - b. The final proposal public notice;
 - c. Every submission;
 - d. Every appeal/objection; and
 - e. "Such information concerning the communities of interest and population of the district or region or local board area or community, or any proposed ward or constituency or subdivision, as is held by the territorial authority or regional council and is necessary for the purposes of section 19R."

- 4. Section 19R of the Act enables the Local Government Commission to make any inquiries that it considers appropriate to make a determination and may hold meetings with the council "or any persons who have lodged an appeal or objection and have indicated a desire to be heard by the Commission in relation to that appeal or objection."
- 5. The Local Government Commission is considering 44 representation reviews across New Zealand this year and has until 11 April 2022 to release its final decision to QLDC.

Wānaka Lakefront Development Stage Three

- 6. Completion of stage three was delayed slightly by the Level 4 lockdown and the proposed opening of the boardwalk on 23 September 2021 is no longer occurring. A proposed replacement date is 11 October at 1.00pm and members of the Wānaka Community Board are invited to attend.
- 7. It is hoped that Aukaha and iwi representatives will also be able to attend to provide a karakia and a blessing for the site

Minor Improvements

8. Advice has recently been received that Council has received funding to undertake work at both Capell Avenue and Golf Course Road. Staff are not yet in a position to make a presentation to the Board about this but anticipate being able to do so at the next meeting.

Lease to Old Mitre 10 Building

9. Council's Property team are progressing discussions with the landlord of the old Mitre 10 Wānaka building, with the aim of securing the property for a community centre. A building condition assessment has been completed and negotiations continue. Simultaneously, the Sport & Recreation and Property teams are continuing discussions with potential user groups to narrow down spatial requirements and fit-out options. The Property team will bring an update to the Board once lease terms have been finalised.

Activity at Wānaka Recreation Centre ('WRC')

- 10. Below are some highlights from activities at WRC over the last few weeks.
 - Walking Netball continues to grow in popularity and will be run on a regular basis.
 - COVID lockdown meant many programmes were put on hold. In that time, the recreation centre and pool were thoroughly cleaned and prepared for Level 2.
 - Doors to the centre re-opened at level 2 and it was great to once again open the facility to the community and welcome the community back.
 - The next school holidays programme starts on 4 October and a full schedule was released on 13 September.
 - Sports 10 league will be starting again on 11 October pending what happens with alert levels in the coming weeks.
