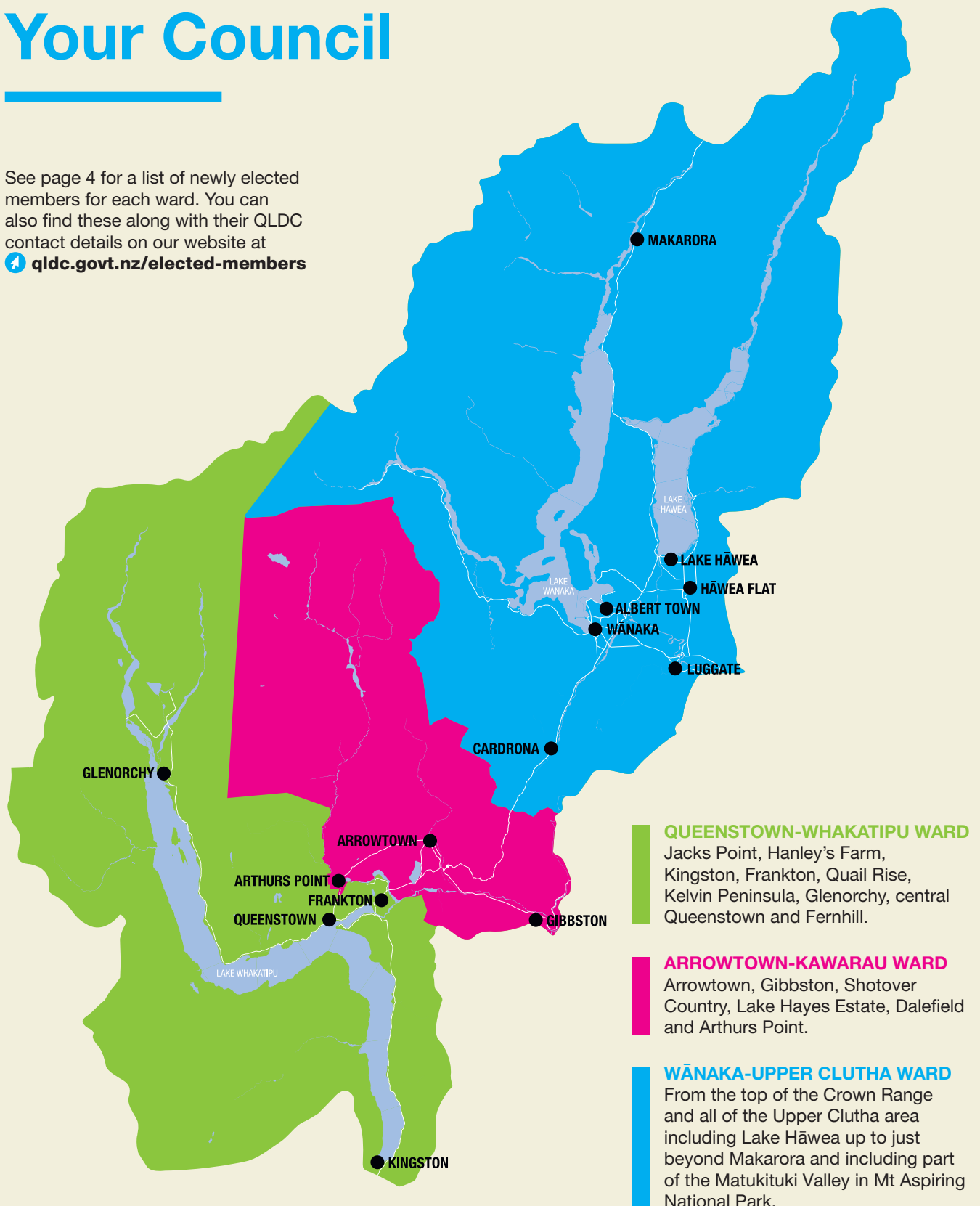

# Local elections 2025: the final results

## MAYOR

**John Glover has been elected as the Mayor of Queenstown Lakes District Council with 4,599 votes.**

The other candidates were: Glyn Lewers (3,244 votes); Nik Kiddle (2,108); Darren Rewi (1,671); Al Angus (874); Daniel Shand (125).

Voting for this year's local body elections closed on 11 October. The final results were confirmed a few days later once all the special votes (made by people under specific circumstances such as not receiving a voting pack in the mail, or not enrolling to vote by the cut-off date but then doing so before election day) had been counted.

QLDC's campaign to promote all stages of the election process – candidate nominations, getting enrolled to vote, providing information on all candidates and then encouraging people to vote – was all wrapped up under the slogan *The Highest Vote*.

Inspired by our district's alpine setting, *The Highest Vote* literally took local democracy to new heights with bright orange voting bins located at Cardrona and Treble Cone ski fields. We also hosted a special one-day voting bin at the Crown Range Road summit lookout that featured on 1News' main evening bulletin!

A total of 17 orange bins were located in supermarkets, sports facilities, libraries and Council offices as well as on the mountains, and we also hosted pop-up polling places at Hanley's Farm and Lake Hāwea.

**Huge thanks to the nearly 13,000 of you who voted. That represented a turnout of 41.16% compared to 43.05% in 2022.**

Local government in New Zealand is required by statute to conduct its elections by post but, in the 24 years since the Local Electoral Act, use of the postal system has declined hugely.

For several years, QLDC has been actively lobbying for reforms such as voting online that would make it easier for people, especially in more remote communities like ours. We look forward to actions at a national level that would address the ongoing downward trend for voter turnout and help support future local campaigns like *The Highest Vote*.

# HOW'S LIFE?

## KEI TE PĒHEA TŌU AŌ?

### QUALITY OF LIFE SURVEY NOW OPEN

The eighth annual Quality of Life survey is open until Sunday 16 November for residents and ratepayers to give feedback on how they feel about life in the district.

All respondents have an opportunity to go in the draw for one of four \$250 Prezzy cards.

Findings from the anonymous survey will provide insights into your views on issues such as housing, health services, the environment, transport, employment and sense of community.

Over time, findings have been crucial in building a long-term picture of how the district is faring, helping QLDC and other public service providers to plan ahead and identify ways to improve the quality of life for people who live here.

While a group of people have been randomly selected from the electoral roll and invited to participate, all ratepayers and anyone living in the district (aged 18 and over) can take part.

Conducted by Versus Research on behalf of QLDC, the survey will take around 15-20 minutes to complete and is available as follows:

# Big response to airport review

Earlier this year, QLDC appointed independent specialist consultancy Egis to undertake a future review of Wānaka Airport. This will set the vision, values, objectives and preferred outcomes for the much-valued community asset.

Over June and July, Egis conducted a first round of district-wide consultation to understand what living, working and playing here meant to locals and what future role the airport should play in this.

The responses then helped Egis develop several possible scenarios which were presented to the community for further feedback over August and September.

This second round of online and in-person engagement closed on 18 September and generated one of the biggest responses - more than 1,100 submissions - we've seen for a specific QLDC project.

As well as direct contact with key stakeholders, the campaign included print, online and radio advertising, prominent signage and – of course – social media.

The Facebook campaign that supported the second round of engagement generated impressive results:

VIEWS – 167,759.  
REACH – 106,230.  
LINK CLICKS – 1,446.

Thank you to everyone who shared their views. Egis now has a robust set of data to inform its final recommendations that will be presented to a public workshop with the incoming Council later this year.

# New measures to manage freedom camping

QLDC's new Freedom Camping Bylaw 2025 comes into effect on 1 December in time for the summer season. It will help us manage this activity in a way that ensures public areas remain safe, protected and accessible to everyone.

We received nearly 400 submissions during a month-long period of community consultation that included drop-in sessions in Wānaka and Queenstown and an online webinar, a recording of which was available on the QLDC website.

The draft bylaw was amended as a result of feedback and then adopted by Councillors in early October.

**Ours is the most popular district for overnight free camping in Aotearoa New Zealand which has led to a range of adverse impacts on land Council controls or manages. Balancing community concerns with what the Freedom Camping Act requires us to do, our new bylaw is designed to ensure visitors continue to enjoy freedom camping here while addressing the concerns of residents.**

## BYLAW BASICS

- > Freedom camping will be allowed in 15 specified sites, subject to conditions: four in Queenstown, three in Wānaka, two in Frankton, and one each in Arrowtown, Gibbston, Glenorchy, Kingston, Lake Hāwea and near Lake Hayes.
- > Rural roads will also allow freedom camping but include conditions such as how close to the road a camper can park.
- > Freedom camping will be prohibited on public roads within our urban areas.
- > Council reserves are not included in the bylaw and will continue to be managed under the Reserves Act. Luggate Red Bridge Reserve is currently the only reserve in the district that allows freedom camping. In October, Council approved several conditions to be introduced here including only using a certified self-

contained vehicle, using one of the 50 marked spaces, and limiting length of stay and arrival/departure times.

- > The Freedom Camping Act applies nationally and permits freedom camping by default on most council land. Local bylaws are limited in both what they can address and the specific area to which they apply.

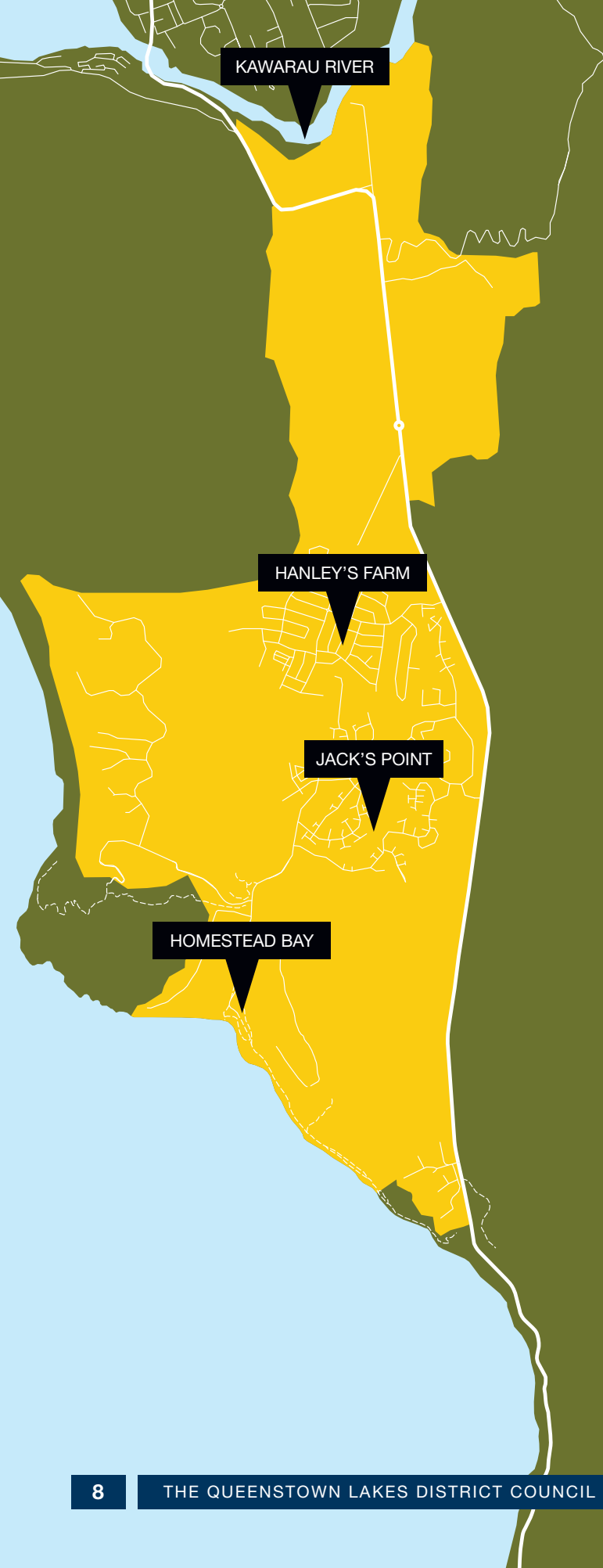
Look out for a comprehensive responsible camping education campaign that will raise awareness of the new rules and make it clear to visitors where and how freedom camping will be permitted.

# Plan to guide southern growth

A plan to guide development and infrastructure south of the Kawarau River around Hanley's Farm and Jack's Point is now in place.

Adopted in early September, the Structure Plan for Te Tapuae Southern Corridor is a 30-year roadmap that identifies where homes, shops and parks will go, how people will get around, and where key services will be placed and staged.

Ultimately, it aims to ensure land at the foot of the Remarkables remains a highly desirable place for people to live, work, play and visit despite predicted rapid growth.

## SOME OF THE KEY CHALLENGES AND OPPORTUNITIES ADDRESSED BY THE PLAN INCLUDE:

Supporting the potential future development of 9,300 mixed-density homes.

Creating three mixed-use commercial centres, new educational facilities and expanded social infrastructure such as parks, sports facilities and a library.

Delivering new/upgraded infrastructure for wastewater, stormwater and water supply.

Enhancing public transport and active travel options to help manage growth-related congestion.

Integrating Kāi Tahu and QEII Trust land values, emphasising biodiversity, mauri (life essence) and sustainable management.

## What we heard from you

Adoption of the Structure Plan followed public engagement held in June and July this year.

Your feedback highlighted the need for a balanced and considered strategy that supports growth while preserving the area's unique character, with a clear aspiration for development to enhance quality of life while being supported by infrastructure when it's needed.

### AS A RESULT, WE MADE AMENDMENTS TO THE FINAL PLAN THAT WAS ADOPTED BY COUNCILLORS INCLUDING:

Adjustments to proposed zoning.

Local centre locations.

Protecting a highly valued landscape strip within Jack's Point.

Additional provision for industrial land and transport infrastructure.

# From the Chambers

---

## 2024-2025 ANNUAL REPORT ADOPTED

Getting the Council's annual report approved before an election every three years always gets close to the wire.

Normally there are a whole four months after the end of the financial year (30 June) to prepare the annual report, but in an election year it needs to be ready a month early to present to the outgoing Council.

This year's team did an amazing job presenting the final report to Council on 9 October – a mere two days before election day.

The annual report is the final stage of Council's planning cycle and it's an important review of all the activities undertaken during the previous financial year.

It also provides an opportunity for the Council's auditors to provide useful feedback. This year they've made several recommendations for consideration by the QLDC Audit, Finance & Risk Committee once it's reformed after the election.

## PARDON THE INTERREGNUM

Council is perpetual but all Council committees are discharged at the time of an election.

Although there are some standard committee structures that can be adopted, the new Council can decide what sort of committees it wants to establish. This doesn't necessarily need to reflect what previous structures were in place.

Once this has been decided, you can find details of all committees, their meeting dates and agendas on our website.

There's also a period immediately following an election when there are no Councillors officially in place. To safeguard against the possibility of Council being unable to respond if something extraordinary were to happen, the Chief Executive is delegated time-limited 'interregnum' powers.

## STOP ME IF YOU THINK YOU'VE HEARD THIS ONE BEFORE

Did you know that in the first nine months of 2025 there were nearly 50% more items presented at Council meetings than in the same period last year. With that in mind, it's perhaps no wonder that not everything could be wrapped up before the election.

The new Council can't act until it's had its inaugural meeting (scheduled for 30 October) and so there'll be a familiar ring to some of the items being presented to Councillors at their first ordinary meeting in November.

Returning to be considered for final approval will be several items from the 2022-25 triennium including the Traffic and Parking Bylaw, the Glenorchy Airstrip Reserve Management Plan, the Dangerous and Insanitary Buildings Policy, and a proposal for an easement over part of Wānaka Golf Course Recreation Reserve.

# Never bin a battery

A fire at Queenstown Transfer Station in August was a close call, and a stark reminder of the danger posed by improper disposal of batteries.

Batteries are the leading cause of fires in collection trucks, landfills and waste facilities. When crushed or damaged, they can ignite and cause serious harm to infrastructure, workers and the environment.

**QLDC's Solid Waste team would like to remind everyone to never put batteries (or items containing batteries) in kerbside or public rubbish and recycling bins. This includes AA/AAA, lithium-ion, car, e-scooter and e-bike batteries, vapes, and rechargeable batteries.**

Before throwing anything away **always** check to see if it contains a battery. Common examples are smartphones, laptops, electric toothbrushes and remote-controlled toys.

# A word on rates

## THE EASIEST WAY TO PAY IS VIA DIRECT DEBIT

A direct debit automatically deducts the amount required at the specified frequency, and we offer weekly, fortnightly, monthly or quarterly payment options.

## GET A RATES REBATE

The government's rates rebate scheme allows an annual rebate of up to \$790 for low-income earners (below \$64,000 household income) who have been paying rates from 1 July 2024.

# Feedback shapes **Queenstown Hill** biodiversity plan



Thanks to everyone who took the time to share their thoughts and provide 92 submissions on the draft Te Tapunui Queenstown Hill Forestry Management Plan during the consultation in June-July.

The plan, adopted by Council on 4 September, proposed to remove all wilding tree species on the reserve and replant the site with a mixed native/exotic forest and scrub/tussock grassland.

In response to community feedback (which showed 76% in support of the draft plan) and comments from submitters that spoke at a public hearing, several changes were made to the final plan before it was adopted, including:

- > The plan's name changing to Te Tapunui Queenstown Hill Restoration Management Plan 2025. This reflects the fact that, while forestry remains a component, the plan's primary focus is the ecological restoration of the reserve.
- > A preference for native plants where appropriate with exotic species only to be planted when they provide clear benefits to the reserve (e.g. helping natives get established by reducing exposure or suppressing invasive species). These changes, including updates to the native and exotic species lists, were made on the basis of recommendations from local ecologists and community groups.

- > Details acknowledging that mountain biking trails are unauthorised and therefore won't be protected during harvesting operations.
- > That development of new logging road infrastructure provides an opportunity to create a new network of walking trails for public use once the site is safe to access again.

## NEXT STEPS

The QLDC Parks team is now working through operational details, including the requirements for a Harvest Plan and an Environmental Management Plan. Due to limited funding in the current Long Term Plan, we'll be exploring potential funding opportunities such as collaboration with the Whakatipu Wilding Conifer Control Group.

Tree removals will only be approved when there is budget for replanting and ongoing maintenance along with a detailed regeneration plan that commits to sustainable restoration.

# Keeping safe on our waterways

Our lakes and rivers will soon be buzzing with activity so here's a reminder that the Navigation Safety Bylaw 2025 is now in force across our district. It's important that locals and visitors alike understand what's changed and how to stay within the rules.

## WHY IT MATTERS

The bylaw reflects extensive community consultation and aims to address emerging safety concerns, improve clarity around waterways use, and ensure fair access for everyone. The bylaw applies to all waterways users, whether you're operating a powered vessel, paddling, swimming or spectating. It also promotes mutual respect and awareness. For example:

- > Keep your speed under 5 knots (fast walking speed) when within 200m of the shore and within 50m of any swimmers or other craft.
- > Stay clear of designated swim zones and ski lanes unless you're participating appropriately.

## KEY CHANGES YOU SHOULD KNOW

**Communication equipment:** All powered vessels must now carry a means of communication (e.g. VHF radio or mobile phone) to ensure help can be reached in emergencies.

**Vessel ID:** New ID requirements mean vessels must be clearly identifiable, helping improve safety, accountability and enforcement.

**Ski lanes:** After public feedback, some ski lane changes have been adopted in the district. These are mapped in Schedule 1 of the bylaw and must be respected.

**Albert Town bridge safety lanes:** To reduce potential conflict between swimmers and vessels. Upstream and downstream passage lanes have been introduced. Jumping off the bridge isn't prohibited, but users must be aware of the new safety zones.

**Event management:** A new framework is in place for managing temporary water-based events, ensuring they don't compromise safety or access for others.

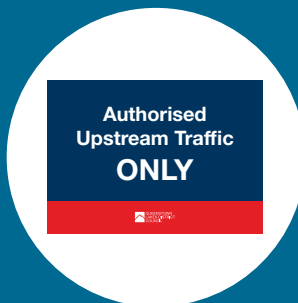

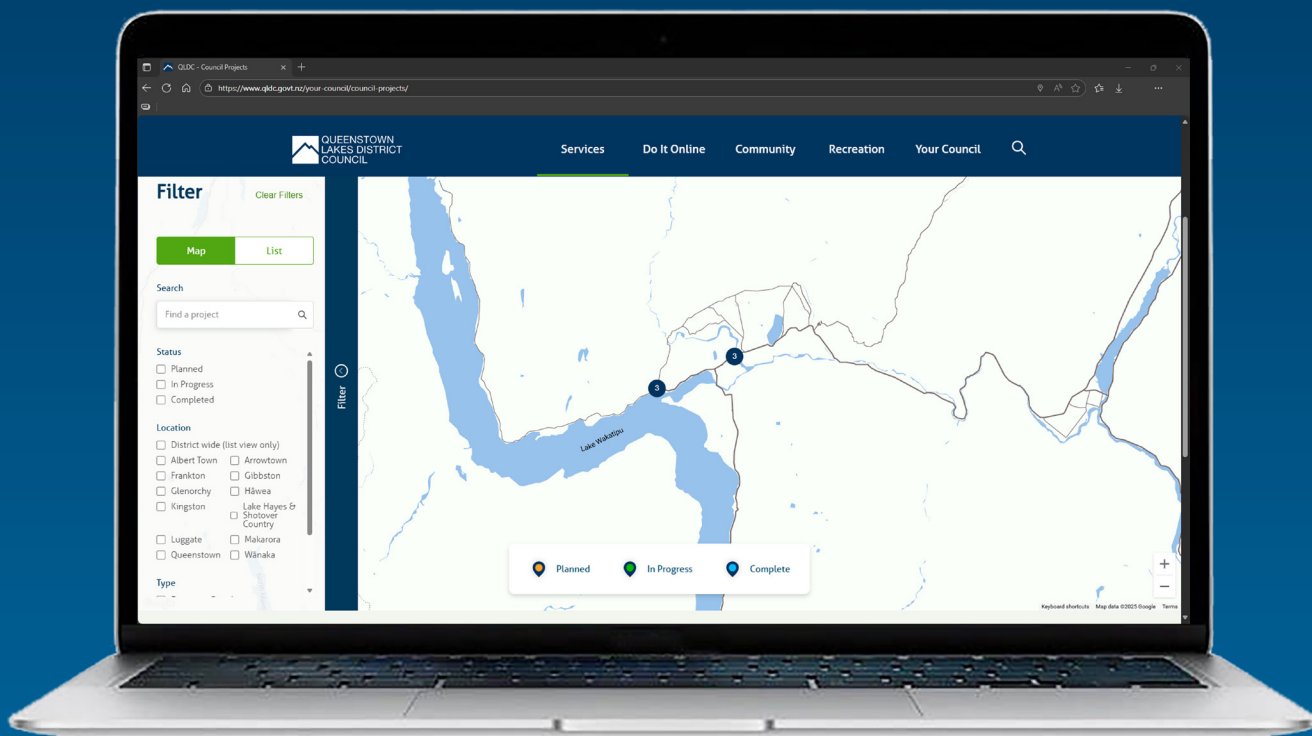

# Upper Clutha wastewater upgrades

Work has started to install over 20km of new pipes between Lake Hāwea township, Albert Town, Wānaka and the Project Pure Wastewater Treatment Plant out by Wānaka Airport. This is all part of a range of significant upgrades that will:

- > respond to and future proof Lake Hāwea's wastewater needs;
- > minimise the chance of contaminants entering the environment during the treatment and disposal process; and
- > increase the capacity and resilience of the wider Wānaka and Albert Town wastewater network.

It's a big job designed to meet the needs of our growing population which means some disruption is likely until work is completed in early 2027.

# Spring planting makes good ground

Ka pai to all the awesome volunteers and our Parks team who've been digging, weeding, planting and protecting hundreds of native plants on reserve land.

Whakatipu Reforestation Trust and Te Kākano Aotearoa Trust (based in the Upper Clutha) are two of the local volunteer groups supported by QLDC that in total have planted more than 8,000 natives this season.

## WĀNAKA WETLANDS

There are many special wetlands in Wānaka including one tucked away between Beacon Point Beach and Waimana Place. Te Kākano, Beacon Point Road Restoration Group and WAI Wānaka have been working together to protect it and in September planted 200 native species into the wetland. This time no rabbit protection was required thanks to the bunny-busting mahi of QLDC's biodiversity officer and private landowners who've worked together to reduce numbers. Can you spot the dog in the photo below?



## FIRE HILL – LAKE HAYES ESTATE

Five seed islands containing 300 natives have been planted on Fire Hill in Lake Hayes Estate to help stabilise the hillside, reduce fire risk and build a habitat for returning wildlife. Special mention to Jen Smart who led this work and the support of local residents and Lake Hayes Estate and Shotover Country Community Association. Over the past year 1,000 trees have been planted between Shotover Country (Blackbird Hill) and Lake Hayes Estate.

The plan was developed collaboratively by the Upper Lakes Integrated Catchment Group which includes QLDC, ORC, DOC and LINZ alongside mana whenua and community members representing the Whakatipu, Wānaka, Hāwea and Waiwhakaata/Lake Hayes catchments.

Since August 2024, the group has contributed nearly 900 hours - a significant commitment that reflects its passion and dedication to the wellbeing of the our environment and communities.

# Building a creative, cultural district together

Across the district, creativity, culture and heritage are gaining momentum. From festivals and exhibitions to workshops and hui, participation continues to grow—showing what's possible when our community works together. The creative sector now contributes an estimated \$34 million to the local economy and employs 5.64% of the workforce, second only to Wellington.\*

As the district's Regional Arts Organisation, the Three Lakes Cultural Trust (TLCT) connects people, places and resources to keep creativity visible, valued and viable. In partnership with QLDC, Lakes District Museum & Gallery and community-led groups, TLCT is building a district where creativity and culture are part of everyday life.

The Trust published its first annual report in late-September. As well as reflecting on successes like the four-day Te Muka Toi | Te Muka Tākata hui in Queenstown and Wānaka (pictured) in June, and the launch of TLCT's digital platform Te Wāhi Toi | The Arts Place, the report also contains actions that reflect a clear community message: protect what makes this place special, create spaces of belonging, and put creativity, culture and heritage at the centre of our future.
