## Legal Responsibilities



### What we will cover

- > At the first meeting of a local authority the LGA requires us to provide a general explanation of:
  - > LGOIMA
  - > Local Authorities (Members' Interests) Act 1968
  - > Sections 99, 105, 105A of the Crimes Act 1961
  - > The Secret Commissions Act 1910
  - > The Financial Markets Conduct Act 2013



## **LGOIMA**

### Local Government Official Information and Meetings Act

- > Official information
- > Principle of availability
- > Reasons for withholding in sections 6, 7 and 17
- > Chief executive responsibility
- > Review by Ombudsman



## LGOIMA - Meetings

- > Meetings to be held in public
- > Reasons for excluding public based on official information reasons
- > Formal process for excluding public
- > Public notification
- > Availability of agendas and matters not on the agenda
- > Maintenance of order



### Members Interests Act

- > Contracting rule Disqualifying contracts of elected members (limit of \$25,000 per year)
- > Participation rule Prohibition on discussing or voting on question in which elected member has a pecuniary interest



## Section 6(1)

"A member of a local authority or of a committee ... shall not vote on or take part in the discussion of any matter ... in which he has, directly or indirectly, any pecuniary interest, other than an interest in common with the public."



## Pecuniary Interest

- > Essentially a financial interest of some sort
- Can include financial disadvantage or financial advantage
- > Can be indirect
- > Deemed interests under the Act:
  - > singly or jointly with spouse holds 10% or more of share capital
  - > is managing director or general manager (or spouse is)
  - > member of controlling company / managing director combination Deemed interests



### Declaration of interests

> Member must declare to the meeting that they have a pecuniary interest and abstain from discussion and voting - which must be recorded in the minutes



## Liability of Councillors

- > General indemnity by Council
  - Costs and damages for civil liability if good faith and in pursuance of Council's responsibilities or powers
  - Costs of successful defence of criminal liability relating to acts in capacity as a member
- > Auditor-General may report on unlawful loss members liable, subject to certain defences





## Crimes Act 1961

- > Section 99 definition of "official"
- > Section 105 corruption and bribery
- > Section 105A corrupt use of official information



## Secret Commissions Act 1910

- > Councillor deemed to be an agent
- > Offences relating to accepting inducements or rewards
- > Offence to fail to disclose pecuniary interest in contract
- > Imprisonment, fines, disqualification



## Financial Markets Conduct Act

- Elected members are "directors" whenever Council offers financial products (eg debt or equity securities)
  may be personally liable for registered documents (eg disclosure statements) containing false or misleading information
- > Elected members can be "information insiders" and subject to civil and criminal penalties for trading breaches in relation to listed companies (eg where member possesses material information relating to a listed issuer that is not generally available to the market and trades or encourages to trade etc)
