

## Queenstown Lakes District Council Proposed District Plan Stage 3 and 3b Hearings 2020

As set out in the 3<sup>rd</sup> March 2020 'Minute 6 – Hearing Directions', the Independent Hearing Panel for Stage 3 are seeking to achieve an efficient hearing process that allows people a fair and equal opportunity to participate. They will pre-read the submissions and evidence and will also allow people to present at the hearing and answer questions about their submissions.

In order to limit the extent to which multiple parties may present on the same matter saying the same thing, the Chair is encouraging submitters to coordinate with like-minded submitters, and if possible, for groups of submitters to nominate a representative to present on their behalf. 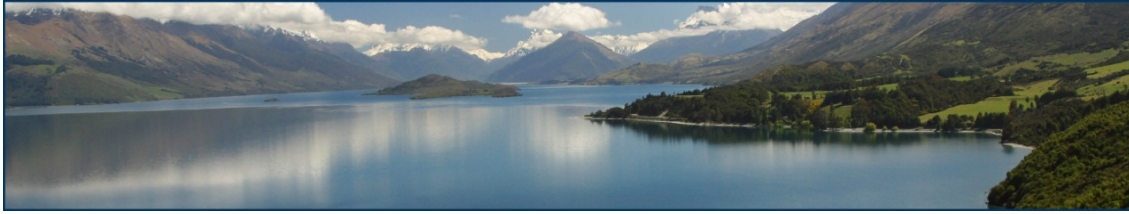
