

Form 17 - Application for New Manager's Certificate

A manager's certificate allows you to work as a duty manager for a business that sells or supplies alcohol.

Notes:

- You must hold the Licence Controller Qualification (LCQ) to apply for a manager's certificate.
- To apply in the Queenstown Lakes district, **you must reside or work in the district.**
- Applicants must have sufficient experience working in licensed premises in New Zealand (usually six months). If you do not have this experience, your application may be placed on hold until you do.
- Applicants should be actively employed in the hospitality industry.
- If you are on a temporary work visa, your certificate will be contingent upon you retaining the right to live and work in New Zealand.
- You may be contacted at any stage if we need more information, or if there is opposition to your application.

5 SUPPORTING DOCUMENTS

Copies of the following documents must be included with the application.

References must be on company letterhead, signed, and dated within the past month. They must state your job title, start and end date(s), and alcohol-related duties. A job description cannot be accepted in lieu of a reference.

Current Photo ID – Must be either passport, New Zealand Driving Licence or Hospitality NZ card (18+ or Kiwi Access).

Your LCQ certificate. Course pass letters cannot be accepted.

Your LCQ bridging course certificate (if applicable).

A reference from your current employer – see note above for reference requirements.

If you have been with your current employer less than six months: one reference from a previous NZ employer (or, if not possible, a relevant Australian employer). See note above for reference requirements.

Your work visa/residency/citizenship confirmation (if applicable). This should be a copy of your current visa in your passport or a letter from Immigration NZ, which must show the expiry date.

If on a work visa: your Job Description. Please ensure the job title matches your visa and employer's reference.

Your RSA certificate (if applicable – the RSA is a certificate provided in Australia to show that an individual has successfully completed the 'Responsible Service of Alcohol' training course).

If the application is signed by someone else on behalf of the applicant, a letter from the applicant stating that they give permission for that person to act on their behalf.
