CONTEXT | HOROPAKI

Representation Review

- 1. The Council adopted its final representation review proposal at the Council meeting held on 16 September 2021. The main details of the final proposal as it relates to the Wānaka area were:
 - a. To retain the existing ward boundary;
 - b. To rename the existing structures as Wānaka-<u>Upper Clutha</u> Ward and the Wānaka -<u>Upper Clutha</u> Community Board;
 - c. Four Councillors will be elected in the Wānaka-Upper Clutha Ward (an increase from the present three);
 - d. Four members will be elected to the Wānaka-Upper Clutha Community Board (status quo);
 - e. Three of the Wānaka-Upper Clutha Ward Councillors will become members of the Wānaka-Upper Clutha Community Board as appointed members, and this will be determined by Council. This is a change from the current situation where the three Wānaka Ward Councillors all serve as appointed members of the Board.

2. Appeals and objections to the Council's final proposal closed on Friday, 22 October 2021 and none was received. The Council's proposal was a compliant model so does not need to be referred to the Local Government Commission. Accordingly, the Council's proposal is final and will be implemented from the 2022 election.

Wānaka Lakefront Development

- 3. A small event took place on 11 October to open the Board walk which represented completion of stage three of the Wānaka Lakefront Development. The Mayor, representatives of Aukaha and Board members attended and despite the wet weather, was a very successful event.
- 4. Community feedback on the concept plan for Stage Five of the Wānaka Lakefront Development Plan is currently open until 5.00pm on Sunday 7 November. The concept plan released as part of the consultation is appended as Attachment C.
- 5. Stage Five of the Wānaka Lakefront Development Plan runs from the Wānaka Marina through to the Yacht Club, and will see the implementation of a number of features, including:
 - a. Restoration and development of native vegetation, with planting carried out along the bank adjacent to Lakeside Road; and
 - b. The continuation of Te Ara Wānaka a shared pathway for pedestrians and cyclists that connects Wānaka's Town Centre with the Yacht Club and the lakefront trail leading through to Eely Point.
- 6. The community consultation is seeking feedback on what is proposed with the shared pathway and native revegetation as well as any other comments on the proposed development.
- 7. The Parks Team has met with representatives from the Wānaka Marina, the Wānaka Yacht Club, Wānaka Active travel and Wai Wānaka to discuss the concept plans on site.

Activity at Wānaka Recreation Centre ('WRC')

- 8. Below are some highlights from activities at WRC over the last few weeks.
 - Started two new aqua programmes for term 4 Aqua Blast and Deep Water Aqua
 - Additional Yoga class added to Wednesday Mornings Yoga is now run Tuesday, Wednesday and Friday
 - Adjusted swim lane bookings to accommodate alert level 2 requirements
 - Adult Badminton started for term 4
 - Junior Racquet Sports to kick off in term 4, with requests coming through Facebook well ahead of it starting


