Confirmation of Minutes

1. Recommendation to adopt the final Te-Taumata-o-Hakitekura Ben Lomond & Te Tapunui Queenstown Hill Reserve Management Plan

The purpose of this report was to consider recommending to Council that Te-Taumata-o-Hakitekura Ben Lomond & Te Tapunui Queenstown Hill Reserve Management Plan be adopted in accordance with the Reserves Act 1977.

Sophie Craig (Parks & Reserves Planner) presented the item alongside Briana Pringle (Parks & Open Spaces Planning Manager) and Dave Winterburn (Parks Manager).

Councillors sought clarification over the main differences in the 2025 iteration of the plan compared to 2005.

Councillors sought clarification on the statutory requirements for the timeframes for review of the resource management plan. Councillors also sought clarification on the future timeline for the plan, and interdependencies feeding into the plan moving forward.

Councillors sought clarification on the scope and inclusion of climate change in the plan, and whether officers thought what had been included was sufficient. Councillors noted that an emphasis on the inclusion of climate change in any communications circulated about the plan may be of value.

It was moved (Councillor Whitehead, Councillor Bruce):

That the Community & Services Committee resolve to:

- 1. Note the contents of the report; and
- **2. Recommend to Council** to adopt the final Te-Taumata-o-Hakitekura Ben Lomond & Te Tapunui Queenstown Hill Reserve Management Plan.

2. Chair's Report

The purpose of this report was to provide the Community & Services Committee with an update on projects of interest.

Councillor Bruce presented the item alongside Kat Banyard (Senior Parks Advisor), Dave Winterburn (Parks Manager), and Tarsy Koentges (Parks Officer Cemeteries and Heritage).

Councillors sought clarification on the Heritage Incentive Grant funding round process, whether there had been public education around funding opportunities, and whether any changes had been implemented since the last round of funding.

Councillors sought clarification on managing expectations of applicants within the funding round for the Heritage Incentive Grant, specifically where applicants received significantly less funding than requested.

Councillors sought clarification on the Horn Creek clean up, and the level of waste removal required for the clean-up. Councillors also asked where rubbish had collected most along Horn Creek and what contributed to this build up.

It was moved (Councillor Tucker, Councillor Guy):

That the Community & Services Committee resolve to:

- 1. Note the contents of the report; and
- **2. Approve** retrospectively the allocations of the Heritage Incentive Grants for 2024-2025.
