Alert Level Updates

The person limit for gatherings will increase to 100 from tomorrow 29 May. The new limit applies to gatherings at your home, events outside of home and public venues – including church services, weddings, funerals and tangihanga. **Read more**

"Tasman Bubble"

A draft blueprint into how safe trans-Tasman travel could start is to be presented to the New Zealand and Australian Governments in early June. The plan is being put together by a team industry and government experts from both countries called the Trans-Tasman Safe Border Group, which is being coordinated by the Australia New Zealand Leadership Forum. Tourism

Tourism New Zealand has launched the first phase of its domestic campaign, Do Something New, New Zealand. The campaign will run on social media, on demand streaming services and traditional media websites. It follows a social media campaign by TNZ encouraging Kiwis to travel safely as the country transitioned to Alert Level 2 last week. Read more

Destination Queenstown's domestic winter campaign kicks off this Sunday 31 May. This will be a full funnel campaign to stimulate demand and immediate action and has been specifically created to inspire kiwis to travel post-lockdown. Read more

Welfare

The Government has announced a new temporary payment for Kiwis who lose their jobs due to the global COVID-19 pandemic. The COVID Income Relief Payment is being introduced, alongside a wider work programme on possible future employment insurance as we rebuild our economy in a way that supports workers and businesses together. The payment will be available for 12 weeks from 8 June for anyone who has lost their job due to the impact of COVID-19 since March 1. It will pay \$490 a week to those who lost full-time work and \$250 for part-time. The payment will not be taxed. Read more

New Avonhead Travel in Christchurch is organising an Air New Zealand chartered flight to Korea on 8 June and would be grateful if you could forward this information through your networks to help us reach local South Korean citizens who may be interested.

The Auckland to Incheon flight departs at 9am on 8 June and the price for a one-way ticket is \$1800 (economy), \$2400 (premium economy) and \$3750 (business) per person. Domestic flights to Auckland must be organised separately by the traveller.

Southern Lakes Civil Defence Support - From next week, the Queenstown's Civil Defence welfare support service will move to a Monday to Friday operation.

If you have employees or members of your community group who you think may require assistance we ask that you let them know of the change to our hours as they will need to plan ahead to ensure they are not caught short at the weekend. All that has changed is that applications will no longer be processed during the weekend or on public holidays. As Monday 1 June is a public holiday, staff will not be processing requests on this day. People can continue to apply for support via the welfare form on the QLDC website at anytime but need to be aware that requests made using this form will only be processed during business hours, Monday to Friday.

The Otago Helpline (0800 322 4000 or help@otagocdem.govt.nz) will continue to operate 9am to 5pm daily for urgent requests.

If people need help paying rent, power or gas bills they can apply for help from Otago Civil Defence online. Applications made are processed during business hours Monday to Friday.

Queenstown will be the recipient of \$1.4million to support local worker redeployment and labour market activity as part of the Government's redeployment package. Read more

Business Debt Hibernation

Business Debt Hibernation (BDH) allows your business to hibernate existing debts for up to seven months so your business can get back on its feet, rather than putting in place processes such as liquidation. It requires permission from your creditors and means you can continue trading - subject to any restrictions agreed with creditors as a condition of entering into hibernation.

BDH is available to a wide range of businesses including companies, trusts and partnerships who were registered or existed prior to 3 April 2020. It does not extend to licensed insurers, registered banks, non-bank deposit takers and sole traders. Sole traders who become insolvent are instead subject to the Insolvency Act 2006 (which covers personal insolvency) because there is no separation between the trader's business finances and their personal finances. We suggest you discuss the process with your accountant, lawyer or insolvency practitioner.

Applications for loan support close 12 June

Government loans of up to \$100,000 are still available for eligible businesses to help with cash flow. Nearly \$1 billion in support has already gone out to small businesses, including contractors and self-employed.
