

## QUEENSTOWN LAKES PROPOSED DISTRICT PLAN - STAGE 2 - Stream 14 Notice of Hearing: Chapter 24 - Wakatipu Basin and Submissions transferred from Stage 1

The Queenstown Lakes District Council hereby gives notice in accordance with clause 8B of the First Schedule to the Resource Management Act 1991, that the Hearings Panel appointed to consider submissions on the Proposed District Plan (Stage 2) on behalf of the Council will hold a hearing on the following parts of the Proposed District Plan commencing **9 July 2018**:

- Wakatipu Basin Zone and Wakatipu Basin Lifestyle Precinct (Chapter 24) and the zoning and mapping annotations applied to these areas.
- Submissions transferred from Stage 1 relating to zoning in the Wakatipu Basin including zoning in Arrowtown and Lake Hayes Estate, and the location of urban growth boundaries Rural Zone and landscape classification lines in that area and on the Crown Terrace.

You have received this notice because you made a submission on these parts of the Proposed District Plan.
