INTRODUCTION

- This memorandum responds to Direction 16.2 (Hearing Panel Site Visits) in Minute 1 issued by Queenstown Lakes District Council (QLDC) in relation to the Urban Intensification Variation (Variation).
- 2. This memorandum is filed on behalf of John O'Shea, Helen Russell, John Russell and Mary-Louise Stiassny (**Submitters**). The Submitters have been assigned the number Submitter 198 by QLDC.

SITE VISIT LOCATIONS

- 3. The Submitters request that the Hearing Panel undertake a site visit to the Submitters' property and surrounds in Wānaka to view the presence of groundwater springs and Bullock Creek weaving through urban land subject to the Variation. A site visit would also provide more context to the example (Belvedere Apartments) of a more intensively developed site in the Variation area which has had adverse effects on groundwater.¹
- 4. The Submitters request that the Hearing Panel visit the following locations which correspond with the locations on the map at **Appendix A**:
 - (a) A: From Warren Street facing north, view the eastern side of Belvedere Apartments noticing the excavation depth compared to the Wanaka Springs to the east.
 - (b) B: From Warren Street facing north, view the western side of the Belvedere Apartments again noticing the excavation depth, in particular the basement depth at the northern end of the site, and Bullock Creek running alongside the north-western boundary.
 - (c) **C**: From Warren Street facing north, view Bullock Creek running through residential properties.
 - (d) **D**: From Warren Street facing south, view Bullock Creek running through residential properties and along road reserve.
 - (e) **E**: From Helwick Street, view Bullock Creek running through residential properties to the east and west.

- (f) **F**: From Tenby Street, view Bullock Creek running through residential properties to the north and south.
- (g) G: Suggest parking vehicle here at the Submitters' property located at 3/61 Stratford Terrace.
- (h) H: Walk from driveway following red dashed line around to the north side of the Submitter's property and down the stairs to the pond marked at location B in Appendix A. This is the pond referred to in the evidence of Mr John Russell² and Mr Neil Thomas.³ Following the red dashed line will ensure the Panel remain on the Submitters' property.
