Important Notice:

Under Section 369 of the Building Act 2004 a person commits an offence if the person in any communication, application, or document that is required to be made or given under this Act or by the regulations, --

- (a) knowingly makes a written or oral statement that is false or misleading in a material particular; or
- (b) knowingly makes a material omission.

A person who commits an offence under this section is liable [on conviction] to a fine not exceeding \$5,000.00
