1. Queenstown Lakes District Council Libraries Strategy 2020-2030 updated August 2020

A report presented by Ms Sue Gwilliam (District Librarian) and Ms Alex Bassett (Wakatipu Libraries Team Leader) sought endorsement from the Community & Services Committee for the Queenstown Lakes District Council Libraries Strategy 2020-2030 (the strategy) updated August 2020 to be adopted by Full Council.

The report was taken as read.

The Committee discussed the details of the report. Queries were raised regarding smaller catchment areas and possible future expansions. It was clarified that the intention was to work with the smaller communities to implement mobile services and technology hubs for book lending and to rotate collections to create more vibrancy within the libraries to offset the need for further expansion. If a need for expansion was identified in the future, a pop-up library would be created to allow for the demand to be accurately assessed and actioned accordingly.

Councillor Miller arrived at 10.09am.

The Committee noted that the strategy would be reviewed every three years as part of the Long Term Plan process, and that budget allocations were not guaranteed and would need to be considered by the Councillors in order to implement the strategy as intended.

On the motion of Councillors Lewers and Miller the Community & Services Committee resolved to:

 Endorse the Queenstown Lakes District Council Libraries Strategy 2020-2030 and recommend it for adoption by Full Council.
