## **Request for Official Information LG26-0015 - Communications Team**

Dear [REDACTED],

Thank you for your request for information held by the Queenstown Lakes District Council (QLDC). On 16 January 2026 you requested the following information under the Local Government Official Information and Meetings Act 1987 (LGOIMA):

- 1. The average response time to media enquiries submitted to the Council, broken down by year and/or by quarter over the past year.**
- 2. The total salary spends of the communications/media/public relations department, or equivalent team over the past two year.**
- 3. A list of all staff employed within the communications/media/public relations department including:**
  - a. Their job titles or roles;**
  - b. Their corresponding pay bands or actual annual salaries;**
  - c. Whether the positions are full-time, part-time, or contract roles.**

### **QLDC RESPONSE**

In response to your request, we consulted with both the QLDC People and Capability Directorate and the QLDC Communications and Engagement Team.

### **Decision to release information**

- 1. The average response time to media enquiries submitted to the Council, broken down by year and/or by quarter over the past year.**

Response times for media enquiries can vary due to factors outside the Council's control, such as the availability of information, staff leave, or the timing of when queries are received.

For consistency, queries received outside standard office hours are generally recorded as being received the following morning. Minor variations exist in how times are logged by different staff. Media groupings cover multiple outlets, and instances where a response time is recorded as "n/a" generally reflect cases where a reply was sent directly by another staff member and not captured in the media log.

The total salary spend for the QLDC Communications and Engagement Team over the past two years was \$1,926,050.58.

**b. Their corresponding pay bands or actual annual salaries;**

Roles within the Communications and Engagement Team are remunerated in accordance with Strategic Pay market data. The average pay bands across these roles generally range from approximately \$75,000 to \$110,000. A detailed breakdown of individual remuneration will not be provided; the reasons for withholding this information are outlined below.

**c. Whether the positions are full-time, part-time, or contract roles.**

The team comprises 9.8 full-time equivalent (FTE) positions, made up of a mix of full-time and part-time roles. There are currently no contractors or consultants engaged within this function.

**Decision to withhold information**

**b. Their corresponding pay bands or actual annual salaries;**

QLDC have good reason under section 7(2)(a) of the LGOIMA for withholding part of the information requested. QLDC consider it is necessary to withhold part of the requested information on the basis of the following grounds:

- Section 7(2)(a) - the withholding of the information is necessary to protect the privacy of natural persons, including that of deceased natural persons.

Section 7(2)(a) of the LGOIMA is intended to protect the privacy of individuals by allowing information to be withheld where its release would involve the unreasonable disclosure of personal information or could cause harm or distress. This provision seeks to balance the public's right to access official information with the need to respect individual privacy and prevent the misuse of personal information.

In this instance, information relating to salaries is being withheld as it relates to identifiable natural persons. The Privacy Act 2020 upholds individuals' rights to be informed about the collection, use, and disclosure of their personal information. Releasing the requested information could constitute an unreasonable intrusion into the personal affairs of the individual concerned.

In this case, the need to protect the privacy of natural persons outweighs any public interest in the release of the information. Accordingly, the decision to withhold the information is justified and consistent with the provisions of both LGOIMA and the Privacy Act.

### **Public interest considerations**

In assessing whether to withhold information, QLDC carefully evaluates the public interest—particularly whether disclosure would enhance transparency, accountability, or informed public engagement. This assessment includes weighing those benefits against the potential harm that could result from releasing the information.

QLDC acknowledges the public interest in ensuring transparency and accountability among local authority members and officials and supports the principles of good governance. QLDC remain committed to releasing information wherever appropriate. However, in this case, the interest in protecting personal privacy and preventing potential harm or distress to the individuals concerned outweighs the public interest in disclosure.

Therefore, QLDC has determined that section 7(2)(a) of the LGOIMA applies. This provision allows for the withholding of information to protect the privacy of natural persons. In this case, no overriding public interest has been identified that would justify its release.
