Aircraft Pilots and Owners Association v Queenstown Lakes District Council (ENV-2018-CHC-000132) being an appeal against decisions of Queenstown Lakes District Council on the proposed Queenstown Lakes District Plan (**PDP**).

 - (b) Will better achieve the higher order provisions of the PDP, the Otago Regional Policy Statement, and Part 2 of the Act.
- 7 Fairfax & Others are willing to participate in mediation or other alternative dispute resolution of the proceedings.
