### Key messages



## Professional Services spend \$14.1M

Second quarter Professional Services total spend to date is \$14.1m which is 10.1% of total expenditure.

#### **Opex spend**

\$8.2M / 58%

60% or \$4.9M of the \$8.2M total operational professional services spend is within P&D, with \$0.8M weathertightness legal fees, recoverable costs of \$2.2M, and \$1.4M District Planning appeals and hearings costs.

#### **Capital Spend**

\$6.0M / 42%


\$2.6M (44%) driven by ten largest capex projects, the remaining \$3.4M relates to 92 other projects.

#### TOTAL: \$6.0M (42% of total spend)

- > Other CAPEX represents \$3.4M (56%), spread across 92 projects
- > In total, there are 102 projects with an average spend of \$58k Sep YTD.




### OPEX Spend




