BOUNDARY ACTIVITIES

Boundary activities relate to the bulk and location of buildings or structures in relation to a boundary.

The following standards from the Operative District Plan have been identified as boundary activities.

Three Parks (Business SZ)	12.26.6.2 [Ref 2] - Buildings approved by a CDP [permitted]12.26.6.3 [Ref 11] - Building Height [recession plane only]
Three Parks (Commercial Core SZ)	 12.26.7.2 [Ref 5] – Buildings approved by a CDP [permitted] 12.26.7.3 [Ref 5] – Buildings setback from Internal Boundaries 12.26.7.3 [Ref 7] – Sunlight and Outlook of Residential Neighbours
