Hi Craig,

These designations seem to be historic and no longer required to be listed in the district plan. I assume they were rolled over when the current district plan was formulated.

The land areas under the designations are now gazetted as either scenic or recreation reserves under the Reserves Act, which is the purpose for which the land was required originally.

As it is unusual for DOC to hold land designations and there will be no implications for not continuing to hold these four designations, it is therefore considered that these can be removed from the plan through this review.
