Key messages



Professional Services spend

\$21.3m / 12%

Decrease as a percentage of total supplier spend compared to prior years

Weather tightness

\$2.9m / 27%

Over a quarter of the operational professional services spend relates to defending weather tightness claims

Capital Spend

\$10.7m / 50%

\$4.3M (41%) driven by ten largest capex projects

Consultancy Cost as % of Supplier Sp




TREND: DECREASING

- > FY22 Consultant spend for the first 9 months of FY22 is \$21.3m
- > As a percentage of total supplier spend however, Consultant costs have been steadily decreasing.
 - > Reducing from 19.9% in FY19, to 19.6% FY20 and 16.1% in FY21 and now 12.8% for FY22 YTD.
- > \$21.3M is the spend across both Capex and Opex
 - > Half being driven by Opex \$10.6m (50%) and of this \$2.9m relates to weather tightness (Wynn Williams, GHD Ltd, Hadley Consultants, Lane Neave and Simpson Grierson).



- > In total, there are 132 projects with an average spend of \$84k




OPEX Spend






OPEX Analysis


