What do I need to do?

You <u>must</u> file your submission and all of your supporting documents in advance of the hearing within the timetable set out in this minute.

When do I need to file evidence?

Applicants must file written submissions and other supporting documents with the DLC by 3pm Wednesday 24 September 2025. Copies of this information will be provided to all parties to this application the same day.

Police, the Medical Officer of Health and Objectors who have confirmed their attendance must file written submissions and other supporting documents with the DLC by **5pm Thursday 16 October 2025**. Copies of information received from these parties will be sent to the applicant on Friday 17 October 2025.

Applicants must file final written rebuttal submissions with the DLC by 5pm Thursday 23 October 2025. Copies of this information will be provided to all parties to this application on Friday 24 October 2025.

As there is no ability to cross examine other parties, the DLC may ask questions on behalf of each party. Questions to the DLC regarding information provided in the submissions and supporting documents, must be filed with the DLC by 5pm Friday 31 October 2025.

If you cannot comply with the timetable above, you must make a written application to the District Licensing Committee to vary it urgently. Any application must be made in a timely manner. Any such application will be referred to the Chairperson for directions and response.

The hearing will commence at the time and date set out in the revised Notice of Hearing which will be provided in due course. Additional information regarding timetabling of matters each day will follow in due course and be provided to parties in advance of the hearing.
