- (a) Amendments to provisions to ensure appropriate weight is given to benefits that can be derived from earthworks and associated activities.

**Chapter 29 (Transport)**

- (b) Amendments to provisions relating to reduction in use of private vehicles and the roading network and parking requirements for visitor accommodation and commercial activities.

**Chapter 38 (Open Space and Recreation Zones)**

- (c) Activity status of activities in the informal recreation zone

- 7 The Parties support the relief sought in part, insofar as it is consistent with the relief sought in each of the Parties appeals.

8 The Parties agree to participate in mediation or other alternative dispute resolution of the proceedings.
