Skyline operates an iconic tourism facility within the proposed Open Space and Recreation Zone and the Ben Lomond Sub-Zone and supports the proposed zoning (with amendments) to recognise and manage the existence, extent and further development of commercial and informal recreation activities in the Ben Lomond Recreation Reserve. Skyline supported the proposed zoning in submission 2493. As the operator of these facilities and being the lessee of the majority of the land contained within the Ben Lomond Sub-Zone Skyline has an interest greater than the general public in this submission.

THE REASONS FOR MY SUPPORT (OR OPPOSITION) ARE /

The submitter opposes the Open Space and Recreation Zone and the Ben Lomond Sub-Zone and seeks amendments to the provisions to manage the interface between the KBP site and the Skyline lower terminal. No alternative provisions are suggested in the submission and therefore the extent and type of additional restrictions or consideration to be provided to this issue in the Objectives and Policies if the submission is allowed are unknown.

Accordingly, the relief sought by the submitter in submission point 2569.10 is opposed.

Skyline has an interest greater than the public generally in this submission as they are the operator of the Skyline gondola and lessor of the land identified to the west of the Kiwi Birdlife Park and included in the Ben Lomond Sub-Zone.
