

Plan Change 27 – Updating District Plan References

Proposed changes

The changes proposed by this Plan change are as follows. Additions are <u>underlined</u> and deletions are shown as strikethrough.

- 1. Amend Zone Standards 5.3.5.2 as follows:
- 5.3.5.2 Zone Standards

iv Surface of Lakes and Rivers

(a) Motorised craft on the surfaces of lakes and rivers shall be operated and conducted such that a maximum noise sound level (Lmax) of 77_dBA L_{ASmax} is not exceeded, when measured and assessed in accordance with Appendix 2.

Noise

...

Non-residential activities shall be conducted such that the following noise levels are not exceeded, neither at, nor within, the notional boundary of any residential unit, other than residential units on the same site as the activity:

- (a) during daytime (0800 to 2000 hrs) L10 50dBA.
- (b) during night time (2000 to 0800 hrs) L10 40dBA and Lmax 70dBA. except:
 - (i) When associated with farming and forestry activities, this standard shall only apply to noise from stationary motors and stationary equipment.

(ii) Noise from aircraft operations at Queenstown Airport is exempt from the above standards.

Construction noise shall comply with and be measured and assessed in accordance with the relevant New Zealand Standard.

- (a) Sound from non-residential activities measured in accordance with NZS 6801:2008 and assessed in accordance with NZS 6802:2008 shall not exceed the following noise limits at any point within the notional boundary of any residential unit, other than residential units on the same site as the activity:
 - (i) <u>daytime</u> (0800 to 2000 hrs) 50 dB L_{Aeq(15 min)}
 - (ii) <u>night-time (2000 to 0800 hrs)</u> 40 dB L_{Aeq(15 min)}
 - (iii) <u>night-time (2000 to 0800 hrs)</u> 70 dB L_{AFmax}
- (b) <u>Sound from non-residential activities which is received in another</u> zone shall comply with the noise limits set in the zone standards for that zone.
- (c) <u>The noise limits in (a) shall not apply to construction sound which</u> <u>shall be assessed in accordance with NZS 6803:1999.</u>
- (d) The noise limits in (a) shall not apply to sound from sources outside the scope of NZS 6802:2008. Sound from these sources shall be assessed in accordance with the relevant New Zealand Standard, either NZS 6805:1992, NZS 6807:1994 or NZS 6808:1998.
- (e) <u>When associated with farming and forestry activities, the noise</u> <u>limits in (a) shall only apply to sound from stationary motors and</u> <u>stationary equipment.</u>
- (f) <u>The noise limits in (a) shall not apply to sound from aircraft</u> operations at Queenstown Airport.



2. Amend Zone Standards 5.7.5.2 as follows:

5.7.5.2 Zone Standards

... iii Noise

Non-residential activities shall be conducted such that the following noise levels are not exceeded, neither at, nor within, the notional boundary of any residential unit, other than residential units on the same site as the activity:

(a) during daytime L₁₀ 50dBA

(b) during night time L₁₀ 40dBA and L_{max} 70dBA

except:

(i) Nothing in this rule applies to the use of agricultural vehicles, machinery or mobile portable agricultural machinery, wind machines and frost fighting devices whether stationary or not, operated in accordance with the manufacturer's specifications. This rule shall also not apply to the use of bird scaring devices which rely upon the generation of noise for the efficiency of the device.

Provided that:

No single event of noise (L100) shall exceed 85 dBA measured at the notional boundary 20m from a dwelling house on an adjacent site.

Construction noise shall comply with and be measured and assessed in accordance with the relevant New Zealand Standard.

(a) <u>Sound from non-residential activities measured in accordance</u> with NZS 6801:2008 and assessed in accordance with NZS 6802:2008 shall not exceed the following noise limits at any point within the notional boundary of any residential unit, other than residential units on the same site as the activity:

- (i) <u>daytime</u> (0800 to 2000 hrs) 50 dB L_{Aeq(15 min)}
- (ii) <u>night-time (2000 to 0800 hrs)</u> 40 dB L_{Aeq(15 min)}
- (iii) <u>night-time (2000 to 0800 hrs)</u> 70 dB L_{AFmax}
- (b) <u>Sound from non-residential activities which is received in another</u> zone shall comply with the noise limits set in the zone standards for that zone.
- (c) <u>The noise limits in (a) shall not apply to construction sound which</u> shall be assessed in accordance with NZS 6803:1999.
- (d) The noise limits in (a) shall not apply to sound from sources outside the scope of NZS 6802:2008. Sound from these sources shall be assessed in accordance with the relevant New Zealand Standard, either NZS 6805:1992, NZS 6807:1994 or NZS 6808:1998.
- (e) The noise limits in (a) shall not apply to sound from bird scaring devices, agricultural vehicles, machinery or mobile portable agricultural machinery, wind machines and frost fighting devices whether stationary or not, operated in accordance with the manufacturer's specifications. Sound from these sources measured in accordance with NZS 6801:2008 and assessed in accordance with NZS 6802:2008 shall not exceed 85 dB L_{AFmax} at any point within the notional boundary of any residential unit, other than residential units on the same site as the activity.



3. Amend Zone Standards 6.2.5.2 as follows:

6.2.5.2 Zone Standards

iv Noise

On any site, activities shall be conducted such that the following noise levels are not exceeded at any Residential Zone boundary or at any boundary of Activity Areas 1, 3, 4, 6 and 7 of the Remarkables Park Zone:

0800 2000 hrs 55dBAL₁₀ (Monday to Saturday)
 2000 – 0800 hrs 45dBAL₁₀ and 70dBA L_{max}

- (a) Sound from activities measured in accordance with NZS 6801:2008 and assessed in accordance with NZS 6802:2008 shall not exceed the following noise limits at any point within any Residential Zone or at any point within Activity Areas 1, 3, 4, 6 and 7 of the Remarkables Park Zone:
 - (i) <u>daytime</u> (0800 to 2000 hrs) <u>55 dB L_{Aeq(15 min)}</u>
 - (ii) <u>night-time (2000 to 0800 hrs)</u> 45 dB L_{Aeq(15 min)}
 - (iii) <u>night-time (2000 to 0800 hrs)</u> 70 dB L_{AFmax}
- (b) <u>The noise limits in (a) shall not apply to construction sound which</u> shall be assessed in accordance with NZS 6803:1999.
- (c) The noise limits in (a) shall not apply to sound from sources outside the scope of NZS 6802:2008. Sound from these sources shall be assessed in accordance with the relevant New Zealand Standard, either NZS 6805:1992, NZS 6807:1994 or NZS 6808:1998.

- 4. Amend Zone Standards 7.5.5.2 as follows:
- 7.5.5.2 Zone Standards Residential Activities and Visitor Accommodation in the High Density Residential Zone

Visitor Accommodation activities shall be so conducted that the following noise limits are not exceeded at any point within the boundary of any other site within this zone:

 Daytime 0800- 2000 hours
 50dBA L₁₀

 Night-time 2000- 0800 hours
 40dBA L₁₀ and 70dBAL_{max}

Noise levels shall be measured and assessed in accordance with NZS 6801:1991 and NZS6082:1991.

- (a) Visitor accommodation activities conducted within the Residential Zone shall not exceed adjoining zone noise limits at any point within the boundary of any site within that adjoining zone.
- (b) Activities conducted in adjoining zones shall not exceed Residential Zone noise limits at any point within the boundary of any site within the Residential Zone.
- (a) <u>Sound from visitor accommodation activities measured in</u> <u>accordance with NZS 6801:2008 and assessed in accordance</u> <u>with NZS 6802:2008 shall not exceed the following noise limits at</u> <u>any point within any other site in this zone:</u>
 - (i) <u>daytime</u> (0800 to 2000 hrs) 50 dB L_{Aeq(15 min)}
 - (ii) <u>night-time (2000 to 0800 hrs)</u> 40 dB L_{Aeq(15 min)}
 - (iii) night-time (2000 to 0800 hrs) 70 dB L_{AFmax}



All motorised craft operating on the surface of lakes and rivers within the District must have and display a current acoustic certificate of fitness. Testing shall be undertaken on a strictly controlled "test" day, and shall be conducted by an enforcement officer appointed pursuant to the Act.

The measured sound pressure level shall not exceed a maximum A weighted level:

(L max) of 77dBA for vessels to be operated between the hours of 0800 to 2000; or

(L max) of 67dBA for vessels to be operated between the hours of 2000 to 0800

- (a) $\frac{77 \text{ dB } L_{ASmax}}{0800 \text{ to } 2000;}$ for vessels to be operated between the hours of
- (b) <u>67 dB L_{ASmax} for vessels to be operated between the hours of 2000 to 0800.</u>

TEST CONDITIONS

The following instrument shall be used:

- (i) A Type 1 Precision sound level meter and an acceptable wind screen. A class 1 sound level meter and an acceptable wind screen.
- (ii) A sound level calibrator.

Test Procedure -

- (iii) A wind speed anemometer.
- (iv) An engine speed tachometer.
- Measured Quantities "A" weighted, fast slow response sound level, expressed in decibels (dB).

Principally that the maximum A – weighted sound pressure level indicated during the passage of the craft be retained. The sound level will be accumulated as the craft passes at right angles to the microphone and will be measured until the craft has travelled a distance of 25 m. The meter shall be set for fast response.

> Two passes shall be made and the mean value of the measurements rounded to the nearest integral decibel shall be obtained. If the sound intensity is louder along one side of the craft, then the measurements shall be conducted at this side. The background noise level shall be recorded and shall be at least 10dBA lower than measured level for the boat being tested.

> All craft may not be able to be recorded according to the above method and any deviation shall be in compliance with ISO 2922:1975(E) ISO 2922:2000 or ISO 14509-1:2008. Other statistical and accumulated sound levels may also be recorded and retained for evaluation.
