- APAG also comments on plan changes and Council consultations as these relate to Arrowtown.
- APAG is the lead advocate for the implementation of the Arrowtown Design Guidelines within Arrowtown.

APAG supports the relief sought because—

- The ADG are a document developed with strong community consultation. They have been refined, tested, and implemented as statutory documents for the last 20 years.
- APAG believes there is no scope to remove the ADG as an assessment matter.
- The ADG should be reinstated as an assessment matter within the Proposed District Plan.
