TOWAGE FEES IN RELATION TO PARKED VEHICLES	Amount (NZ\$)
Where expenses are incurred by an enforcement authority in respect of the movement or proposed movement of the vehicle involved in the offence (<i>whether or not the vehicle is in fact moved</i>), the infringement fee shall be the total of the amount specified in respect of the offence AND the appropriate towage fee.	
Towage - 3500kg or less, between the hours of 7am and 6pm, Monday to Friday (not including public holidays)	\$90.20
Towage - 3500kg or less, any other time (e.g. Saturday, Sunday or a public holiday)	\$120.30
Towage - more than 3,500kg, between the hours of 7am and 6pm, Monday to Friday (not including public holidays)	\$223.40
Towage - more than 3500kg, any other time (e.g. Saturday, Sunday or a public holiday)	\$343.70
