PURPOSE OF THE REPORT | TE TAKE MO TE PURONGO

1. The purpose of this report is to present proposed amendments to the terms of reference and delegations for the Wānaka-Upper Clutha Community Board for consideration as a recommendation to Council.

CONTEXT | HOROPAKI

3. The Wānaka-Upper Clutha Community Board is not a committee of the Queenstown Lakes District Council but an unincorporated body as defined by subpart 2 section 51 of the Local Government Act 2002 (LGA 2002), established under section 49 and in accordance with schedule 6 of the LGA 2002.

4. Unlike a committee of Council that is discharged under schedule 7 clause 30(7) of the LGA 2002 at the triennial election, a community board and any powers delegated to it under schedule 7 clause 32 of the LGA 2002 persist until amended by resolution of Council.

5. The Wānaka-Upper Clutha Community Board currently has an extensive terms of reference and a high level of delegation across many matters within the Wānaka-Upper Clutha Ward, including (but not limited to) powers to act relating to parking, cemeteries, local roads, temporary local road closures, street naming, recreation and reserve areas, sports fields, trees, and elderly persons housing. The Board also has numerous powers to recommend including (but not limited to) rates and charges to be levied in the Wānaka-Upper Clutha Ward, any bylaws required for the safety or good governance of the Wānaka-Upper Clutha Ward, and setting policy on the leasing or licensing of use of Council property.



6. Responsibilities of the Wānaka-Upper Clutha Community Board as defined by the existing terms of reference are detailed as to:

- Represent, and act as an advocate for, the interests of its community.
- Consider and report on all matters referred to it by the Council, or any matters of interest or concern to the Wānaka-Upper Clutha Community Board.
- Maintain an overview of services provided by the Council within the community.
- Prepare an annual submission to the Council for expenditure within the community.
- Communicate with community organisations and special interest groups within the community.
- Encourage an integrated strategic approach to long term issues and opportunities to inform board decision-making and key Council processes and documents.
- Undertake any other responsibilities that are delegated to it by the Council.

7. The members of the Wānaka-Upper Clutha Community Board have reviewed the existing terms of reference and delegations, and have proposed a number of amendments to remove duplication or inconsistency with other documents, bylaws, legislation and Council resolutions. The amendments are also proposed to provide the Wānaka-Upper Clutha Community Board with greater visibility and input over matters which the members believe are important to retain local oversight. These have been initially considered by staff and responses provided based on requirements of relevant legislation, operational efficiency and maintaining a consistent level of service throughout the district.

8. The final list of proposed amendments is provided in the *Analysis and Advice | Tataritanga me nga Tohutohu* section of this report for consideration by the Wānaka-Upper Clutha Community Board.

9. The following amendments are proposed to the terms of reference and delegations for the Wānaka-Upper Clutha Community Board:

- Duplication with Code of Conduct and Standing Orders removed.

- Board members able to participate in the decision making for a number of matters signalled as opportunities for them to add value and represent community views.
- Omissions from the existing delegations addressed.

11. <u>Option 2</u> Do not recommend the proposed amendments and engage in further discussion about proposed amendments

Advantages:

• Further opportunity to consider other delegations and terms of reference.

Disadvantages:

• Potential for Council to adopt the amendments proposed in this report delayed.

12. This report recommends **Option 1** for addressing the matter because it addresses a number of inconsistencies and provides increased opportunity for Board and community input on a number of matters, whilst retaining the ability to further review (and if appropriate amend) the delegations and terms of reference at any time in the future.

13. This matter is of low significance, as determined by reference to the Council's Significance and Engagement Policy because it does not significantly affect the wider community and creates consistency with legislation, policies and Council resolutions.

14. The persons who are affected by or interested in this matter are the Wānaka-Upper Clutha Community Board, Council staff, and members of the public that may engage with Council on matters relating to the proposed amended delegations.

15. The Council is not required to consult on this matter.
