Notice of Intention to Revoke Recreation and Local Purpose Reserves – 45-49 Frankton Rd, Queenstown

PURSUANT TO SECTION 24 OF THE RESERVES ACT 1977

The land described in Schedule A of this Notice (the Land) known as Paddy Burton Memorial Park is vested in the Queenstown Lakes District Council under the Reserves Act 1977 as recreation and local purpose reserves.

Waka Kotahi New Zealand Transport Agency would like to acquire part of the reserves to legalise as State Highway as part of the wider Arterials project. The Council is considering the reserve revocations and subsequent disposal of the Land, pursuant to Section 24 of the Reserves Act 1977 as the Land is no longer needed for reserve purposes because:

- a. The Land is not being actively used for reserve purposes; and
- b. The Land is only a small portion of the reserve situated at this site and the wider Queenstown area; and
- c. The Land has little value as recreation and local purpose reserve; and
- d. The Land is proposed to be formed as State Highway following reserve revocation, increasing the access to the remaining reserve; and
- e. Will enable the Land to be considered for potential disposal to Waka Kotahi New Zealand Transport Agency as State Highway.

Pursuant to Section 24 of the Reserves Act 1977 the Council has an obligation to publicly notify its intention to revoke the reserve classification by way of this Notice.

Proposal to Stop Legal Road

KAWARAU HEIGHTS, LAKE HAYES ESTATE, QUEENSTOWN

Queenstown Lakes District Council, under Section 342(1)(a) and Schedule 10 of the Local Government Act 1974, proposes to stop a portion of unformed legal road at Kawarau Heights described as that parcel of land containing 5,257m2 being section 1 on survey office plan 570191

The unformed legal road to be stopped extends off Herries Lane in Lake Hayes Estate, Queenstown and is approximately 520 metres in length and 10 metres wide. It is proposed that once stopped the land would be sold to the adjoining owner Queenstown Commercial Ltd and amalgamated with the title to their land. Once sold it is proposed that the land would be developed as part of the Kawarau Heights development.
